\_\_\_\_ Hour(s) of Wedding Ceremony Service: 30 min Prelude, 30 min Ceremony. Includes specialized Ceremony Microphones, Music and Sound System so your guests hear every word.

\_\_\_\_ Hour(s) of continuous Wedding Reception Service performance time from Steve Myers DJ Bandstand for Cocktails, Dinner & Dancing. Includes Sound System for your reception room plus 2 wireless microphones for welcome, blessing and/or toasts.

3 Planning Sessions - Onboarding, Detailing, Finalizing - to create your wedding ceremony and reception timelines and choose music, including access to Steve Myers' extensive library, exclusive playlists and custom edits.

### ENTERTAINMENT AGREEMENT

**THE PARTIES** This Agreement is for Steve Myers DJ Bandstand Entertainment services for the Event described herein, between the undersigned Client and Steve Myers.

**SERVICES PROVIDED** Steve Myers agrees to provide personnel (Steve Myers) who will be on time with proper attire, equipment and music. Steve Myers agrees to furnish Steve Myers DJ Bandstand Entertainment services to the Client specifications listed herein.

**NON-REFUNDABLE BOOKING FEE:** The Non-Refundable Booking Fee must be included with this Agreement. Event Date will not be considered reserved until this Agreement (signed by Client) and Non-Refundable Booking Fee are received by Steve Myers. The Non-Refundable Booking fee will be credited towards the Total Cost of Services.

### BALANCE

**DUE:** The Balance Due for the Total Cost of Services must be paid in full to Steve Myers no less than 14 calendar days before Event Date. Failure of Client to pay Balance Due more than 14 days in advance of Event Date may result in Client losing reservation of services provided by Steve Myers. Client understands and agrees to this provision.

**PAYMENT:** American Express, Discover, MasterCard, PayPal, Venmo, VISA and personal or business checks are accepted. A \$25 service charge will be assessed for returned checks, plus any bank service charges incurred by Steve Myers. Client understands and agrees that a returned check for the Non-Refundable Booking Fee may result in Client losing reservation of Event Date at the discretion of Steve Myers.

**CANCELLATION POLICY:** Should an act of God prevent Steve Myers from fulfilling this Agreement, Steve Myers shall not be held liable. Every reasonable effort will be made to contact Client immediately to discuss options for the Event Date and Steve Myers will make every reasonable effort to find a replacement at the agreed-upon fees. Should Steve Myers be unable to procure a replacement, Client shall receive a full and prompt refund of all fees paid, including the Non-Refundable Booking Fee. Client agrees that

under all circumstances, Steve Myers liability shall be exclusively limited to an amount not to exceed the Total Cost of Services and that Steve Myers shall not be liable for indirect or consequential damages arising from any breach of contract.

Should the Client cancel this Agreement due to an act of God, the Client will not be held liable, but the Non-Refundable Booking Fee will not be refunded. If the Client for any other reason cancels this Agreement less than 90 days prior to Event Date, the Client agrees to promptly pay the Balance Due. #### ADDITIONAL PROVISIONS:

Client shall ensure Steve Myers is provided with one dressed table for equipment located next to the dance floor.

Client shall ensure Steve Myers is provided with sufficient electrical power located within 50 feet of set up area.

Client shall ensure for an outdoor performance, Steve Myers is provided with shelter that completely covers and protects Steve Myers equipment and personnel from weather conditions.

Client shall ensure reasonable steps will be taken to protect Steve Myers equipment and personnel and that crowd control will be provided if warranted.

Client accepts full responsibility and is liable for any damages, injuries, or delays that occur as a result of failure to comply with these provisions. In the event of circumstances deemed by Steve Myers to present a real or implied threat of injury or harm to Steve Myers equipment or personnel, Steve Myers reserves the right to cease performance until such time as the threatening situation is resolved. Client shall be responsible for payment in full regardless of whether the situation is resolved or whether Steve Myers resumes performance. In order to prevent equipment damage or liability arising from accidental injury to any individual attending this performance, Steve Myers reserves the right to deny any guest access to the sound system or other equipment. Client agrees to indemnify and hold Steve Myers harmless for any property damages or personal injury to Client and third parties, which are not the direct result of its negligence or misconduct.

**OVERTIME RESTRICTIONS:** Agreement provides \_\_\_ hours of continuous performance time (to include wedding ceremony and reception) from Steve Myers on Event Date. Client may purchase Overtime service at \$500 per each additional hour, payable in advance and non-refundable, up to 48 hours prior to Event Date. Overtime service may not be purchased on Event Date, or during Event. Prior Event Location approval required and other Event Location restrictions may apply; one performance location only on Event Date at Event Location. Client must be present at Event Location and

Steve Myers reserves the right to end performance when fewer than 25 guests are in attendance at Event Location.

**MUSIC POLICY:** Steve Myers maintains a huge legally purchased music library of clean [non-explicit] songs, covering almost every decade, style and genre with brand new songs added every week. To prevent playback problems during your event, Steve Myers will not rely on cellular or wifi networks to play songs outside of the Steve Myers DJ Bandstand music library to include: Apple Music, Spotify, YouTube, any other streaming or internet music sources, and Client or guest devices of any kind.

**MODIFICATIONS AND QUALIFICATIONS:** The terms and conditions described in this Entertainment Agreement are the **ONLY** binding terms of this Agreement. All attached or enclosed pages, music lists, planners or any other forms are **NOT** considered a part of this Agreement. This Agreement supersedes any and all prior oral negotiations or agreements. No changes may be made to this Agreement, unless both the Client and Steve Myers initial the changes as being mutually acceptable.

**DIGITAL SIGNATURES:** By accepting this proposal and digitally signing, digital signatures confirm that all parties have read and accepted each provision and all terms and conditions of this Agreement. Event Date is not considered reserved until this Agreement (digitally signed by Client) and Non-Refundable Booking Fee are received by Steve Myers (dates are booked on a “first come, first served” basis).
